Sub: Calling for applications for "Fresh" Departmental Scholarship for Technical / Non-Technical courses for the Academic year 2017-2018

Applications are hereby called for, in connection with Departmental Scholarships to the children of the staff working in Circle Office and allied units for the Academic year 2017-2018.

Scholarship will be given in the first year of the Technical / Professional Degree courses to those students who got admission on the basis of Competitive entrance examination Rank, on the basis of percentage of marks in 12th class (i.e. based on the intermediate and its equivalent examinations passed March / April 2018 with a minimum of 75% marks and above is eligible for the scholarship. No scholarship is admissible to students who secure admission against Management quota / NRI Seats. The institution must be recognised / affiliated to University / AICTE / MCI / UGC etc.

The Heads of Office /Unit Head should certify the correctness of the Date of Birth of the wards as well as Basic pay of the Officers/Officials for awarding Technical and Non-Technical Scholarships and the Basic pay of the wife/Husband if employed (if not employed " a declaration to this effect from the officer/official may be obtained and enclosed). In case of officers/officials belonging to SC/ST and OBC, Heads of offices should certify to that effect (Copy of the caste certificate should be enclosed.)

A Specimen blank application on APP:51(Revised) together with the instructions are enclosed herewith. All the controlling officers/Head of the offices/ above unit Heads are requested to verify the application before submission to this office and ensure that the employee encloses all the requisite documents along with the application. Applications should be submitted to the AD(SR) % CGMT, BSNL Telangana Circle, Hyderabad " on or before 14.10.2018.

Applications received with incomplete information /without requisite documents and received after the due date(i.e. 14.10.2018) will not be processed / considered.

SCHOLARSHIP TO THE CHILDREN OF BSNL EMPLOYEES FOR TECHNICAL /NON-TECHNICAL EDUCATION FOR THE ACADEMIC YEAR 2017-2018

Scope of theme:

These Scholarships shall be awarded to the children for "Technical / Non-Technical Education". The

courses eligible to be considered for scholarship are:

ELIGIBILITY:

- (a) There is No Basic Pay Limit to apply the Scholarship for Technical Courses noted at Sl.No.1 { i.e., Engineering/ Medical and other professional courses of FOUR years and above duration }. of
- (b) The Basic Pay Limit for scholarship for all other courses noted from S1.Nos.2 to 6 { including those meant for handicapped children studying in Recognised colleges } is Rs.38621/- per month. For the First Year of all the courses noted noted from S1.Nos.2 to 6, a minimum of 75% marks and above is required to become eligible for the scholarship.
- (c) The ward of employees should be studying in Recognised Colleges/Institutions.
- (d) Where both the Husband and wife are employed in BSNL, the Pay of the Employee getting the higher pay will be reckoned to decide the admissibility of scholarship to the ward.
- (e) At a time scholarship is admissible to a maximum of two children. In case more than two children are studying, the employee has the option to indicate the two children for whom the scholarship is to be granted.
- (f) Dependent brother and sister are not eligible for scholarship.
- (g) Scholarship is admissible to the spouse of an employee if he/she is pursuing studies in Technical/Non-Technical courses and is wholly dependent on the employee and has no source of income of his/her own.
- (h) Scholarship can be given for the second and subsequent years of study even if scholarship was not applied for the first year .
- (i) Scholarship is not payable to the students of Medical and allied course during the period of Internship when stipends are usually paid by the Institutions .
- (j) Scholarship once awarded shall continue till completion of the course subject to fulfillment of the condition of marks in the annual examination, even in cases of death, invalidation/retirement or superannuation of the employee before the completion of the course.

- (k) For Renewal of scholarship for students of MBBS/BDS/BVSc/BAMS/BHMS the scholarship for 2nd and subsequent years will be renewed only if he/she has secured 55% marks in the 1st / previous years of the course and for all other Technical / Non-Technical Courses, the scholarship for 2nd and subsequent years will be renewed only if he/she secured 65% marks in the 1st / previous years of the course . However , a relaxation of 10% marks will be allowed in respect of such students who are physically handicapped / SC / ST / OBC and girl-child.
- (1) Scholarship is not admissible for Post Graduate Students .
- (m) VALUE: The amount of Scholarship will be as under .
